



What's Your Food Story: Monthly Contesting Terms and Conditions

Skill testing question required. Open to legal residents of Ontario who are 18 years or older. Odds of winning will depend on number of eligible entries received before Contest closes.

ELIGIBILITY

- 2) The Contest is open to all residents of Ontario who have reached the age of majority at the time of entry, except employees (and those with whom such employees are domiciled), Board of Directors (and those with whom such employees are domiciled) of Grain Farmers of Ontario (the "Sponsor"), its affiliated companies or agents, advertising and promotion agencies.

THIS INFORMATION WILL ONLY BE USED FOR ELIGIBILITY VERIFICATION AND/OR CONTACTING WINNERS AND WILL NOT BE RELEASED TO OR USED BY ANYONE OTHER THAN GRAIN FARMERS OF ONTARIO FOR WHATS YOUR FOOD STORY CONTESTING DETAILS.

ALL ENTRIES WILL ALSO AUTOMATICALLY BE ENTERED INTO GRAND PRIZE DRAW.

- 4) You will receive one (1) Entry in each monthly contest period when you follow submission rules. LIMIT (1) ENTRY PER PERSON for EACH MONTHLY CONTEST PERIOD. Entrants can enter into multiple monthly themed contest periods but only (1) entry per monthly contest period. If it is discovered that you attempted to enter more than once during each Monthly Contest Period, then all your Entries will be void. Use of any automated system to submit Entries is prohibited and will result in disqualification.

In Guelph, Ontario, at approximately 10:00 a.m. ET, one (1) eligible entrant will be selected by random draw from all eligible entries during the Contest Periods. The odds of winning depend on the number of eligible entries received.



- 6) Before being declared a winner: The selected entrant will be contacted by email and notified that they are eligible to win. The selected entrant must reply by email within one (1) business day of notification.

The selected entrant must first correctly answer a mathematical skill-testing question to be administered by form through email. The Sponsor will then email, and the selected entrant will be required to sign and return within one (1) business day of notification a declaration of eligibility and a liability/publicity release, which: a. confirms compliance with the contest rules; If a selected entrant: (i) cannot be contacted by email within one (1) calendar days of selection or there is a return of any prior notification as undeliverable; (ii) fails to correctly answer the skill-testing question; or (iii) fails to return the contest documents within the specified time, the he/she will be disqualified and will forfeit the prize, and the Sponsor reserves the right to select an alternate entrant from among the remaining eligible entries.

GENERAL

- 8) By entering the Contest, each entrant agrees to abide by these Contest Rules. This Contest is subject to all applicable federal, provincial and municipal laws. Void where prohibited by law. The decisions of the Sponsor with respect to all aspects of this Contest are final and binding on all entrants without right of appeal.
- 9) Sponsor reserves the right to cancel, suspend, withdraw or amend this Contest in any way, without prior notice or obligation, in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or any other cause beyond the reasonable control of the Sponsor that interferes with the proper conduct of this Contest as contemplated by these Contest Rules. Any attempt to deliberately undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.



- 10) All Entries are subject to verification at any time and for any reason. The Sponsor reserves the right to remove any videos deemed to contain inappropriate content, hate speech, political or activist propaganda or content that is offensive. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any Entry entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Rules. Failure to provide such proof to the satisfaction of the Sponsor in a timely manner may result in disqualification in the sole and absolute discretion of the Sponsor.
